Product Description

- Soluble antibacterial combination for oral administration to cattle in milk replacers or starter feeds
- Each pound of powder contains 100 grams of oxytetracycline activity and 100 grams of neomycin sulfate



- Free-flowing soluble powder.
- Ingredients: Oxytetracycline hydrochloride, neomycin sulfate.

- Type A Medicated Article for use in the manufacture of medicated dry feeds (not for use in liquid feeds except milk replacers).

Indications

 Cattle: Treatment of bacterial enteritis (Escherichia coli); treatment of bacterial pneumonia/ shipping fever complex (Pasteurella multocida); control and treatment of colibacillosis (E. coli).

Withdrawal Period

- 5 days.

Calves (milk replacer)

For Calves (up to 250 lb): for treatment of bacterial enteritis caused by Escherichia coli susceptible to oxytetracycline; treatment and control of colibacillosis (bacterial enteritis) caused by Escherichia coli susceptible to neomycin. Feed continuously for 7-14 days in milk replacers or starter feed. Treatment should continue 24 to 48 hours beyond remission of disease symptoms.

Calves, Beef Cattle, and Nonlactating Dairy Cattle

For treatment of bacterial enteritis caused by Escherichia coli and bacterial pneumonia (shipping fever complex) caused by Pasteurella multocida susceptible to oxytetracycline; treatment and control of colibacillosis (bacterial enteritis) caused by Escherichia coli susceptible to neomycin. Feed continuously for 7-14 days in feed or milk replacers. Treatment should continue 24 to 48 hours beyond remission of disease symptoms.
